Please find enclosed a description of my teaching, research, and service for the period between July 1, 2013 -July 1, 2014, as well as relevant updates related to my AY 13-14 contributions since my last progress towards tenure report:

OVERVIEW

On September 1, 2010, I joined the School of Public and International Affairs as a tenure-track Assistant Professor in the Negotiations and Conflict Management graduate program at the University of Baltimore. I spent the previous year as a Visiting Assistant Professor in the Division of Legal, Ethical, and Historical Studies in the College of Arts and Sciences. This is my eighth consecutive year of full-time teaching experience at the university level and my fourth on the tenure-track. I joined the University of Baltimore after spending two years as a Lecturer at the University of Massachusetts Boston where I taught in the John W. McCormack Graduate School of Policy Studies. I previously taught at Bentley University, George Mason University, and Tufts University, after receiving my Ph.D. in 2006.

At the University of Baltimore, I serve as the director of the Negotiations and Conflict Management program and founding co-director of the Global Affairs and Human Security graduate program in the School of Public and International Affairs.

My research focuses on the intersection of transnational terrorism, counterterrorism, and international conflict management. I frequently speak on policy-oriented matters in Washington, D.C. and participate in scholarly conferences around the world. My early research – including my first book and several journal articles – involved quantitative analyses of terrorism incident data and examined the impact of preemptive force on terrorist activity. Since this time, I have gone on to publish in peer-reviewed journals on topics related to evidence-based counterterrorism policy, terrorism courses, counterinsurgency, suicide terrorism, and the concept of regime change. My latest work has involved both peer-reviewed scholarship and policy-oriented writing on the the Islamic Republic of Iran, a government frequently cited as the most significant state-sponsor of contemporary terrorism, and their democratic political opposition.

In spring 2013, I received an "Exceptional" rating in a merit evaluation issued by the Dean of the College of Public Affairs Stephen Percy for contributions in teaching, research, and service over a three-year period between 2010-2013 (see enclosed letter issued by Dean Stephen Percy).

Dr. Larry Thomas, Executive Director of the School of Public and International Affairs, also noted in his AY 12-13 annual review:

My teaching evaluations, both in the form of narrative assessments and summary reports, remain consistently strong. Detailed analyses of course evaluations since 2006 and table/graphs for 2009-12 appeared in my progress towards tenure report delivered in spring 2013. Additional descriptive information related to each of the courses is available in an addendum attached to my CV.

In my "Annual Report" issued on June 1, 2013, Executive Director of the School of Public and International Affairs, Dr. Larry Thomas, noted that:

"...his {Ivan Sascha Sheehan's} student evaluations are among the highest I have seen during all my years serving both as a faculty member and as an administrator at UB."

In addition to formal lecture and discussion based courses, I continue to direct the CNCM internship program (experiential in nature), serve as an advisor to the graduate student associations in CNCM and GAHS, supervise student research, and mentor students and junior faculty, professionally and academically, in pursuit of their own goals.

In fall 2013, I presented at the Center for Excellence in Learning, Teaching, and Technology (CELTT) 2013 Teaching and Learning Day on panels related to pedagogical uses of storytelling in the classroom and challenges related to the implementation of capstone and sophomore seminars. This is my second time speaking at a CELTT event on pedagogical topics.

I also participated in an American Association of Universities and Colleges (AACU) workshop on using rubrics to advance program-level assessment and enhance teaching at the University of Baltimore on February 21, 2014. The workshop was sponsored by the Center for Excellence in Learning, Teaching, and Technology (CELTT) and facilitated by the General Education Council.

RESEARCH, SCHOLARSHIP, POLICY ORIENTED WRITING & PRESENTATIONS

An overview of important accomplishments related to my scholarship, presentations, policy-oriented writing, media appearances, consultancies, and awards since my last annual report in spring 2013 appears below.

Academic Publications - AY 13-14

Since my last review, I have published or submitted the following publications to peer-reviewed journals:

Published-

- I published an article titled "Challenging a Terrorist Tag in the Media: Framing the Politics of Resistance and an Iranian Opposition Group" in the *Digest of Middle East Studies*, a peer reviewed journal published by Wiley-Blackwell on behalf of the Policy Studies Organization (Vol. 22, Issue 2). Using a content analysis of 367 news and opinion articles in major world news publications over 9 years, the paper examined the way political challenges are framed in the media and the obstacles otherwise marginalized political actors face in trying to gain media attention and influence policy debates.
- I published an article titled "Conflict Transformation as Counterinsurgency" in the March 2014 edition of *Peace Review: A Journal of Social Justice*. The article involved an empirical examination of the increasing usage of conflict transformation concepts in the context of counterinsurgency doctrine. Peace Review is a peer-reviewed journal published by Taylor and Francis Group, LLC/ Routledge that addresses current issues and controversies that underlie the promotion of a more peaceful world.

Since my last review, I published a foreword in a scholarly monograph that I also edited. Specifically:

I authored the foreword and served as an editor for a monograph by Ambassador Lincoln P. Bloomfield, Jr. titled *The Mujahedin-e Khalq (MEK) – Shackled by a Twisted History* that was published on May 1 (after my progress towards tenure files were last submitted). Since this time, fourthousand copies of the monograph were provided to members of Congress, White House Officials, the intelligence community, senior policy analysts in Washington, and prominent elected official in the European Union. The monograph was favorably reviewed by senior U.S. officials and national security experts including General George W. Casey, Jr., Lieutenant General Dell L. Dailey, General James L. Jones, Judge Michael B. Mukasey, Dr. Mitchell B. Reiss, and Governor Bill Richardson. The publication has also since been translated into Farsi. In June 2013, Dr. Mitchell Reiss, President of Washington College and former director of policy planning staff at the U.S. State Department under Secretary Colin Powell, penned a book review in The Baltimore Sun titled *How the U.S. Hung a Potential Iranian Ally Out to Dry*. In July 2013, Governor Tom Ridge, former Secretary of Homeland Security, penned a book review titled *The Friends Left in the Shadow of War* in The Washington Times. An interview featuring a discussion of my work on Iran policy is also scheduled to be published in the next issue of the University of Baltimore Magazine (print and online).

Submitted-

- I submitted a paper titled "Are Suicide Terrorists Suicidal? A Critical Assessment of the Evidence" to a peer-review journal. The paper is under review and has received favorable preliminary reviews. It is expected to be published in fall 2014.
- I submitted a paper titled "Unpacking the Concept of Regime Change from Within" to a peer-review journal. The paper is currently under review.

• I completed a paper titled "The Center of Gravity in Iran and the Case for Supporting Regime Change from Within in Iran." I am currently considering which peer-review journal to send it to. It will be under review shortly.

In Preparation-

• I am currently working on a paper preliminarily titled "Minority Perceptions of Terrorism and Counterterrorism at Historically Black Colleges and Universities in the Mid-Atlantic: Student Narratives and Competing Perspectives of George W. Bush and Barack Obama in the White House" with Dr. Renita Seabrook in the School of Criminal Justice. The study is in a data collection stage but documents have been prepared for submission to the Human Subjects Review Board.

Copyrighted Research Scales-

During AY 13-14, I completed significant updates to the Sheehan Homicidality Tracking Scale (S-HTS), a scale that grew from a presentation on suicide terrorism delivered at an international conference in San Francisco in May 2013. A publication is in progress on the scale.

Peer-Review for Prominent Academic Publishers - AY 13-14

During AY 13-14 I was:

- Invited to serve as peer-reviewer for *University of California Press* where I carried out a blind review of book manuscript on drone warfare featuring a foreword by Archbishop Desmond Tutu.
- Invited to serve as peer-reviewer for the *British Journal of Political Science* published by Cambridge University Press, a leading journal in the field of Political Science.
- Invited to serve as peer-reviewer for the *International Journal of Decision Sciences, Risk, and Management* (IJDSRM) for an article that cited my evidence-based terrorism scholarship heavily.

Presentations at Academic Conferences - AY 13-14

Since my last review, I have delivered presentations, chaired panels, or served as a discussant at the following academic conferences:

National/International Invited Presentations in AY 13-14

- On May 21, I delivered a talk on suicide terrorism at the Annual Meeting of the American Psychiatric Association in San Francisco. The talk examined the social, political, cultural, and economic factors implicated as sources of suicide terrorism from an interdisciplinary perspective. The talk was part of a symposium titled *The Changing Face of Suicide: Assessment, Treatment, Epidemiology, Cultural Issues, and the Emerging Problem of Suicide Terrorism.*
- Between October 2-4, I delivered a paper at the 36th Annual Global Studies Conference at the University of Nebraska, Omaha.
- On October 5, I delivered a presentation at the 2013 International Studies Association's joint
 International Security Studies/ International Security and Arms Control Section Conference at the
 Elliott School for International Affairs at George Washington University. I also served as the chair
 and discussant for a panel.
- On November 6, I delivered a keynote address at The Washington D.C. Summit on Cross Continental Cooperation. The Summit addressed themes related to *Future Prospects in Enhancing Cross Continental Cooperation to Secure Political, Economic, and Social Progress.*

- On January 9, I delivered a paper at the 85th Annual Meeting of the Southern Political Science Association in New Orleans. The paper, part of a panel titled *Terrorism and its Consequences*, involved an empirical analysis of contemporary terrorism courses at 106 top-ranked universities and colleges in the United States. The article was previously published in the peer-reviewed journal *Perspectives on Terrorism*.
- On February 27, I delivered a paper at the 2014 Middle East Dialogue, a conference hosted by the Policy Studies Organization in Washington, D.C. My talk, *Clarifying a Contested Concept: Regime Change from Within*, traced the evolution of the concept of regime change from within and argued that meaningful policy demands more precise articulation of the term.
- Between March 26-29, I delivered a paper at the International Studies Association's 55th Annual Convention in Toronto, Canada. I also chaired two panels and served as a discussant for a panel. The ISA Annual Conference is the leading conference in the International Relations field. I have been invited to present, chair, and serve as a discussant at ISA for three consecutive years.
- On April 15, I delivered a paper at the annual meeting of the Political Studies Association in Manchester, England. Founded in 1950, the Political Studies Association is the leading Association in the field in the United Kingdom, with an international membership including academics in political science and current affairs, theorists and practitioners, policymakers and researchers.

Policy-Oriented Commentary - AY 13-14

"Op-eds enable academics to bring their perspective and expertise beyond the usual reach of academic circles and into the public sphere." -Sommer & Maycroft, 2008

Overview-

Since my last review, I have published **14** new policy-oriented editorials in major news outlets, 1 of them with Georgetown professor and former National Security Council Staffer, Dr. Raymond Tanter. My commentary has been featured on MSNBC, syndicated around the world, and translated into Farsi and French. The commentary has also been shared via social media thousands of time via Twitter and Facebook between AY 13-14. As a demonstration of global readership and social impact, several articles have been tweeted hundreds of time in less than a week (see, for example, multiple articles in the congressional newspaper *The Hill*) and language from my commentary on Iran policy is increasingly showing up in remarks delivered by senior U.S.

public officials.

- On June 14, I along with Dr. Raymond Tanter, former Reagan White House Official and Senior Staffer at the National Security Council, published an op-ed titled "The Opposition on the Eve of the Iranian Elections" with United Press International on the need for the U.S. officials to make evidencebased assessments of the Iranian regime and their opposition in the wake of the tightly controlled presidential elections.
- On September 4, I published an op-ed in the *Diplomatic Courier* titled "During Debate on Syria, U.S. Officials Must Also Protect Iranian Opposition" that examined the September 1 assault on Iranian dissidents at Camp Ashraf as a violation of the quadripartite agreement signed by the Iraqi government and ratified by the U.S. government and the United Nations on August 17, 2012.
- On October 18, I published an op-ed titled "Time for Scholars to Examine Iranian Opposition" through *United Press International (UPI)* on the need for the academic community to consider the wisdom of existing Iran policy in light of recent violence directed at the Iranian opposition detained in Iraq.
- On October 23, I published an op-ed titled "Use al-Maliki Visit to Send Iran a Clear Message" in the congressional newspaper *The Hill* on the need for the White House to press the Iraqi leader to explain the recent massacre of Iranian refugees in northeast Iraq and signal a shift in policy toward Tehran. This article was featured on MSNBC in advance of Iraqi Prime Minister Nouri al-Maliki's visit to the White House on Nov. 1.
- On November 15, I published an op-ed titled "Turn up Heat on the Iranian Regime" in the global affairs section of the congressional newspaper *The Hill*.
- I published an op-ed titled "Mandela's Legacy Lives on in Iranian Resistance" at *Townhall.com* on December 10, 2013. The commentary was published on the anniversary of Human Rights Day and as world leaders gathered in Johannesburg to celebrate the life of former South African President Nelson Mandela.
- My op-ed "Mandela's Legacy Lives on in Iranian Resistance" was subsequently syndicated and picked up by two congressional newspapers *The Hill* (12/13/13) and *Roll Call* (1/7/14) in Washington, D.C. The commentary was also translated into Farsi and French for international consumption (12/16/13).
- On January 20, I published an op-ed titled "Stiffen the Penalties on Iranian Non-Compliance" in the congressional newspaper *The Hill*. The commentary addressed why the U.S. Senate should enact bipartisan legislation to address shortcomings in White House Iran policy.
- On February 11, I published an op-ed titled "Facing the Facts on the Iran Agreement" at Townhall.com. The commentary made the case for prompt passage of the Nuclear Weapons Free Iran Act, as well as measures to protect the intelligence capabilities of the Iranian opposition detained in Iraq.
- On February 19, I published a revised op-ed titled "Face the Facts on Iran Agreement" at *The Hill* as world powers gathered in Vienna to discuss a comprehensive agreement to curtail Tehran's nuclear program. The commentary addressed immediate actions needed by the U.S. Congress to correct Iran policy.
- The policy recommendations in my commentary in *The Hill* on February 19, 2014 were subsequently featured in a detailed segment on Iranian National television. My commentary was also translated on February 19 into Farsi and featured in a prominent Iranian newspaper, Hambastegimeli.

- "Facing the Facts on Iran Agreement" was syndicated through the Augusta Free Press on February 26, 2014.
- I published an article titled "The Ivory Tower and the Iranian Regime" at *Townhall.com* on March 4 in response to a column in The New York Times by Nicholas Kristof on why scholars should examine policy issues and inform the public discourse.
- As of April 2014, <u>www.professorsheehan.com</u> has generated close to 5,000 unique views originating from 78 countries.

Presentations/ Participation in Policy Forums & Media Appearances – AY 13-14

My academic and policy work over the past year has received growing media attention. Since my last progress towards tenure review:

- I was invited to participate in a policy briefing at the opening of the NCRI US Representative Office in Washington, DC, on April 11, 2013 alongside Amb. John Bolton, Rep. Patrick Kennedy, Gen. James Jones, Ambassador PJ Crowley, Dr. Raymond Tanter, Dr. Alan Gerson, Professor Ruth Wedgewood (JHU/ SAIS), John Sano (former Director of the CIA Clandestine Service), and others. I was interviewed on Iranian National Television on the nuclear negotiations and the need to protect refugees at Camp Liberty.
- I spoke at a Congressional Briefing on Foreign Affairs and National Security in the U.S. House of Representatives on April 24, 2013. The event featured Members of Congress, academics, and policy officials who addressed matters related to the failure of the Iranian nuclear negotiations, the regime's human rights violations, and religious minority persecution in the lead up to this summer's elections. Sheehan's remarks were featured on Iranian National Television.
- At the request of Provost Joseph Wood, I participated in the Council on Foreign Relations Education Conference, chaired by Ambassador Richard Haass, in New York City on April 8, 2013.
- On June 7, I spoke at a book signing at Akin Gump Strauss Hauer and Feld LLP in Washington, DC. The event featured remarks by Ambassador Lincoln P. Bloomfield, Jr., author of a monograph titled *The Mujahedin-e Khalq (MEK)—Shackled by a Twisted History*, and Hal S. Shapiro, former senior counselor to the director of the National Economic Council at the White House and Partner at Akin Gump.
- On June 13, I participated in a roundtable discussion with Ambassador Lincoln P. Bloomfield, Jr. at The Stimson Center in Washington, DC on U.S.-Iran policy and the treatment of the Iranian opposition. The invitation only discussion included a group of former government officials and Iran experts who looked at how information and intelligence about the Iranian opposition led to assumptions and judgments that may have constrained policy formulation over time.
- On June 22, I traveled to Paris as a guest of the Organizing Committee for the Convention of Democracy in Iran to serve as an academic observer at the Annual Conference for Democratic Change in Iran, an international gathering of expatriate Iranians. The event featured remarks from leaders from more than fifty countries, a bipartisan delegation of U.S. policymakers, and academics from around the world. I was interviewed on Iran National Television at the gathering.
- I was invited to serve as an academic observer at gatherings of the Iranian opposition in Washington, D.C. including a memorial for a September 1, 2013 attack on Camp Ashraf at The Willard Intercontinental Hotel and a Human Rights/ Democracy in Iran Briefing in the U.S. Senate on March 12, 2014. The events featured senior former U.S. political officials, military leadership, and distinguished academics.

- On October 9, I spoke at a national security briefing in the U.S. Congress. The event, held in the Rayburn House Office Building, featured members of congress, academics, and policy officials.
- On October 31, I participated as the resident expert in a global Twitter Question and Answer Session on U.S.-Iran policy hosted by the Foreign Affairs Council of the National Council of Resistance of Iran. The online event coincided with Iraqi Prime Minister Nouri al-Maliki's visit to the White House.
- On February 10, I was interviewed on Baltimore's FOX 45 on the threat posed by Iranian warships dispatched to the Atlantic Ocean in advance of the P5+1 nuclear negotiations in Vienna.
- I was invited to Participate in Foundation for Defense of Democracies Conference The Middle East in Transition: Allies, Adversaries and Enemies in Washington, DC on May 1, 2014 at the Mandarin Oriental Hotel. The Washington Forum brings together a high-impact group of foreign and national security professionals for discussions and debates on the most complex issues facing America.

College of Public Affairs

Director, Negotiation and Conflict Management (CNCM)

I have now served as Director of the graduate program in Negotiations and Conflict Management for $3\frac{1}{2}$ years. This service includes, among other things, close collaboration with 2 full time faculty, oversight of 4 adjunct faculty, supervision of 1 Academic Program Coordinator and 1 Graduate Research Assistant, and work

with 1 Academic Program Specialist. It also requires reporting directly to the Executive Director of the School of Public and International Affairs.

Since becoming the CNCM Program Director, I have worked hard to build and maintain a vibrant program that attracts strong students. With creative outreach, including webinars for students, our student recruitment efforts have been very successful. Enrollment has increased by approximately 41% since early 2011 and with a current enrollment of 135 graduate students, CNCM is among the larger graduate program in the College of Public Affairs and one of the largest and most diverse conflict management programs in the country.

The highlights of my service to the CNCM program during AY 13-14 include:

- Service on a faculty search committee. My contributions included authoring the position description
 and preparing the faculty hire justification memoranda for the Executive Director of the School of
 Public and International Affairs, Dr. Larry Thomas and Dean of the College of Public Affairs, Dr.
 Stephen Percy.
- Hiring multiple adjunct faculty to teach in the program, including courses in:
 - ✓ Approaches to Managing Conflict
 - ✓ CNCM Capstone Seminar
 - ✓ The Conflict Management Profession
 - ✓ Transformative Mediation Theory and Practice
 - ✓ Issues in Environmental Conflict
- Participation in several graduate student open houses and orientation sessions.
- Hosting public discussions with graduate student leaders in my capacity as program director.
- Providing revisions and suggestions for marketing initiatives related to the promotion of the program externally.

Co-Director, Global Affairs and Human Security (GAHS)

The Global Affairs and Human Security program launched in fall 2012 and we will graduate our first students in spring 2014. As of fall 2014, the program will consist of 2 co-directors, four fulltime faculty, a program coordinator and a program specialist.

The highlights of my service to the GAHS program during AY 13-14 include:

- Chairing the faculty search committee for the graduate programs in *Global Affairs and Human Security* and *Nonprofit Management and Social Entrepreneurship* during AY 13-14.
- Hiring multiple adjunct faculty to teach in the program, including never before taught courses involving new faculty lines. These hires included:

 - ✓ Adjunct faculty to teach New Approaches to Economic and Social Development
 - ✓ Adjunct faculty to teach Managing NGOs
 - ✓ Adjunct faculty to teach Middle East Politics
- Participating in graduate student open houses and orientation sessions.
- Hosting public discussions with graduate student leaders in the College of Public Affairs in capacity as Program Director.

- Service on a College of Public Affairs Fulbright Advisory Committee Led by Dr. Alan Lyles.
- Hosting Alireza Jafarzadeh, Fox News Foreign Affairs Analyst and bestselling author of The Iran Threat, in spring 2014 to deliver a lecture in the Middle East Politics seminar taught by Dr. Sofey Saidi, an adjunct faculty member that I hired to teach at the University of Baltimore.

In addition, I spent time on each student application and I am proud to report that enrollment has grown from 0 to almost 50 students in just 2 academic years.

Additional College of Public Affairs Service

In further service to the College of Public and International Affairs in AY 2013-14, I:

- Contributed to planning and oversight as a member of the *Certified Public Manager Faculty Board* (Appointed by Dr. Ann Cotton, Director of the Schaefer Center).
- Mentored new junior faculty in the College by meeting with them to discuss annual review processes and provide a perspective on the progress towards tenure review.
- Finally, I am very proud to report that as of my fifth year at the University of Baltimore, I have chaired three faculty search committees resulting in the hire of three highly qualified tenure-track assistant professors and increased the gender and racial diversity of the faculty.
